This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$16,528,160. The total estimated cost of these projects is \$17,919,114.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd and 6th Aldermanic Districts

N. Fratney St. - E. Meinecke Ave. to E. Keefe Ave. and E. Wright St. - N. Palmer St. to the Oak Leaf Trail. (ST320161201) (2984-14-02) File Number 160794: Construct two bicycle boulevards.

Further Resolved, That if surplus 2019 funds become available some or all of the 2020 budget projects may be funded with 2019 funds; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
