Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$196,000 for a total estimated cost of these projects being \$560,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$196,000 with the total cost estimated to be \$560,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

City Wide

Water Alterations -- Developer Funded (WT430200300) Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$74,000). The total estimated cost of this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2020 construction season.

Work by MWW Prior to Paving - (WT410200730) Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$100,000. This project is anticipated

to be completed during the 2020 construction season.

Work Done by Contractor/Paving (WT410200750) Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2020 construction season.

Work Done by Contractor/Sewer Alterations (WT410200770) Water main alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000).

The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2020 construction season.

Suburban Plan Reviews - (WT440200800) Plan Review. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$49,000).

The total estimated cost of this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2020 construction season.

Material Inspection at Various Locations (WT410200880) Water Main Inspection. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$24,000). The total estimated cost of this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2020 construction season.

Various locations

Seal coating of various locations adjacent to the City of Wauwatosa (ST211190138) (Non-assessable Reconstruction Paving Fund -- \$1,000) The total estimated cost of this project including the requested amount is \$10,000. This project was completed in 2019.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
