Substitute resolution authorizing the return of real estate located at 3475 N. Buffum Street, in the 6th Aldermanic District to its former owner Cornice D. Grace and Betty Hood.

Permits return of property owned by the City under conditions imposed by s. 304-50, Milw. Code of Ordinances

Whereas, The property located at 3475 N. Buffum Street, previously owned by Cornice D. Grace and Betty Hood, has delinquent taxes for 2016-2019 and was foreclosed upon pursuant to Sec. 75.521, Wis. Stats., and a fee simple absolute was obtained in favor of the City of Milwaukee dated September 23, 2019 191479; and

Whereas, Cornice D. Grace and Betty Hood would like to reclaim said property by paying all City and County real estate taxes, plus accrued interest and penalties to date of payment, and all costs as sustained by the City in the foreclosing and management of said property since September 23, 2019; and

Whereas, Cornice D. Grace and Betty Hood has agreed to pay all related city charges up until the point that the property is returned, as well as all charges and conditions which are detailed in the letters submitted by the Department of Neighborhood Services, Department of City Development, the Health Department and the Treasurer's Office, as though set forth in this resolution; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that in order to return the property at 3475 N. Buffum Street, a cashier's check must be submitted in the amount indicated by the City Treasurer within thirty

(30) calendar days of the adoption of this resolution; and, be it

Further Resolved, That the City Attorney is then authorized to enter into a stipulation with the former owner to reopen and vacate the City's judgment in Milwaukee County Circuit Court Case No 19-CV-003624. Known as the 2019-2 In Rem Parcel 148, securing the court's order and recording said order with the Milwaukee County Register of Deeds; and, be it
