This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$6,759,000. The total estimated cost of these projects is \$9,968,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

2nd Aldermanic District

N. 69th St. - W. Marion St. to W. Glendale Ave. (WT410200663) File Number 191263: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; (Nonassessable Water Fund Budget Line 6410 -- \$565,000). The total estimated cost of this project including the requested amount is \$600,000. This project is anticipated to be completed during the 2020 construction

Stormwater Quality (Non Assessable Water Quality Projects to meet TMDL Requirements, \$55,000 additional funds). The total estimated cost for this project including the requested amount is \$220,000. The project is anticipated to be completed in 2020.

This project is anticipated to be completed during the 2020 construction season.

W. State St. - 300' +/- east of N. 37th St. to N. 37th St. (SM495190017) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$38,000). The total estimated cost of this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2020 construction season.

The total estimated cost for this project is \$150,000. This project is anticipated to be completed during the 2020 construction season.

Movable Bridge Upgrades (BR100200105): Movable bridge mechanical, hydraulic, and electrical upgrades (City Share Non-assessable Structure Fund - \$175,000). The total estimated cost for this project is \$175,000. The engineering is anticipated to be completed during 2020.

Handicap Ramp work to meet ADA requirements - High Impact south side 2020 Projects (ST216200101) File Number 191263: (Nonassessable High Impact Streets -- \$300,000 additional funds). The total estimated cost for this project including the requested amount is \$1,300,000. This project is anticipated to be completed during the 2020 construction season.

Handicap Ramp work to meet ADA requirements - High Impact north side 2020 Projects (ST216200102) File Number 191263: (Nonassessable High Impact Streets -- \$300,000 additional funds). The total estimated cost for this project including the requested amount is \$1,800,000. This project is anticipated to be completed during the 2020 construction season.
