Whereas, The Judiciary and Legislation Committee of the Common Council has recommended the following positions on the bills hereinafter listed and the Common Council being advised of said matters; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that it hereby approves the following legislative bills and instructs the Division of Intergovernmental Relations to appear before the proper committees to support such bill and use its best endeavors to have the same enacted into law, viz:

#### AB-770/SB-703

Relating to: interest rates on payday loans and loans by licensed lenders.

### LRB-4317

Relating to: making changes related to mixed-use tax incremental financing districts, increasing the amount of time a city or village may extend the life of a tax incremental district to improve

its affordable and workforce housing, allowing a reduction in the amount of certain impact fees, and authorizing local units of government to implement workforce housing initiatives.

AB-834/SB-741 Relating to: public notice of noncandidacy for incumbent local elected officials.

AB-440/SB-479 Relating to: prohibiting discrimination based on hairstyle.

Further Resolved, That the Common Council of the City of Milwaukee is opposed to the following legislative bills and hereby instructs the Division of Intergovernmental Relations to appear before the proper committees in opposition to said bills and use its best endeavors in opposition to the same viz:

AB-802/SB-765 Relating to: criteria for the court to consider when determining whether to use videoconferencing at a proceeding.

AB-803/SB-766 Relating to: using testimony taken by deposition in a criminal trial if witness is at risk of being intimidated.

AB-804/SB-767 Relating to: intimidating a victim of domestic abuse and providing a penalty.

AB-805/SB-752 Relating to: recommendation to revoke parole, probation, and extended supervision if a person is charged with a crime.

AB-806/SB-753 Relating to: acts for which a juvenile may be placed in correctional placement or the Serious Juvenile Offender Program.

AB-807/SB-749 Relating to: mandatory minimum sentence for three or more convictions for retail theft and providing a penalty.

AB-808/SB-745 Relating to: prosecuting a violent felon for the crime of illegal possession of a firearm. AB-809/SB-754

Relating to: earned release from parole or extended supervision and discharge from probation.

AB-817

Relating to: bail for a criminal defendant who is charged with bail jumping.

AB-771/SB-726

Relating to: leasing tax exempt property of a church or religious organization to an educational association.
