WHEREAS, HAPA accepted Travaux's proposal, and HAPA and Travaux successfully negotiated an "Owner's Representation Agreement" in an amount not to exceed \$255,000.00; and

WHEREAS, the Officers of Travaux recommend that Travaux enter into a contract with HAPA; now, therefore, be it

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby approve entering into a contract with Hmong American Peace Academy Ltd. (HAPA) for Travaux Inc. to provide owner's representation services for the HAPA main campus addition project in an amount not to exceed \$255,000.00; and, be it
