THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$2,391,000 for a total estimated cost of these projects being \$2,566,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$2,391,000. The total estimated cost of these projects is \$2,566,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st and 4th Aldermanic District

N. 27th St. and W. Highland Blvd. Bioretention Maintenance Contract (SM499200001) File Number 191657: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements - \$49,000). The total estimated cost of this project including the requested amount is \$59,000. This project is anticipated to be completed during the 2020 construction season.

2nd, 5th and 9th Aldermanic Districts

N. 91st St.and N. 92nd St. Bioretention Maintenance Contract (SM499200003) File Number 191657: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$23,000). The total estimated cost of this project including the requested amount is \$33,000. This project is anticipated to be completed during the 2020 construction season.

4th Aldermanic District

W. St. Paul Ave. - N. 27th St. to N. 35th St. (SM495190012) File Number 181588: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$715,000). The total estimated cost of this project including the requested amount is \$735,000. This project is anticipated to be completed during the 2020 construction season.

6th Aldermanic District

N. 2nd St.-W. North Ave. to W. Center St. (SM499180117) File Number 191657: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$190,000). The total estimated cost of this project including the requested amount is \$195,000. This project is anticipated to be completed during the 2020 construction season.

7th and 10th Aldermanic District

Traffic Island Bioswales - Various Locations (SM499190015) File Number 190518: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$260,000). The total estimated cost of this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2020 construction season.

7th and 15th Aldermanic District

N. Sherman Blvd. Bioretention Maintenance Contract (SM499200002) File Number 191657: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$39,000). The total estimated cost of this project including the requested amount is \$49,000. This project is anticipated to be completed during the 2020 construction season.

13th Aldermanic District

W. Alvina Ave.-S. 1st St. to 640' west of S. 1st St. (WT410200601) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$195,000). The total estimated cost of this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2020 construction season.

W. Mangold Ave. - S. 1st St. to 570' west of S. 1st St. (WT410200602) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$150,000). The total estimated cost of this project including the requested amount is \$165,000. This project is anticipated to be completed during the 2020 construction season.

W. Maplewood Ct. - S. 14th St. to S. 15th Pl. (WT410200615) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$260,000). The total estimated cost of this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2020 construction season.

S. 15th Pl. - W. Mallory Ave. to W. Maplewood Ct. (WT410200616) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$105,000). The total estimated cost of this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2020 construction season.

14th Aldermanic District

E/W. Becher St. - 200' E of S. 1st St. to Kinnickinnic River (WT410200004) File Number 190870: Water main and hydrant alterations. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$130,000). The total estimated cost of this project including the requested amount is \$145,000. This project is anticipated to be completed during the 2020 construction season.

2020 Bioretention Maintenance Contract (SM499200004) File Number 191657: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$275,000). The total estimated cost of this project including the requested amount is \$295,000. This project is anticipated to be completed during the 2020 construction season.
