Substitute resolution relating to the Permanent Historic Designation of the Jefferson Street Historic District at the West Side of Jefferson St. between Mason St. and Wells St. excluding 419-433 E. Wells St. in the 4th Ald. District.

This resolution grants permanent historic designation of the Jefferson Street Historic District at the West Side of Jefferson St. between Mason St. and Wells St. excluding 419-433 E. Wells St. in the 4th Ald. District.

Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21 of the Code of Ordinances, provides that historic sites, structures and districts may be designated by the Common Council upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission, at its May 4, 2020 meeting, by a unanimous vote of five (5) ayes and one (1) excused, recommended historic designation of the Jefferson Street Historic District at the West Side of Jefferson St. between Mason St. and Wells St. excluding 419-433 E. Wells St. in the 4th Ald. District.; and

Whereas, These buildings fulfill the following criterion set forth in s. 320-21-3:

- e-1. Its exemplification and development of the cultural, economic, social or historic heritage of the city, state of Wisconsin or the United States
- e-3. Its identification with a person or persons who significantly contributed to the culture and development of the city
- e-5. Its embodiment of distinguishing characteristics of an architectural type or specimen
- e-6. Its identification as the work of an artistic, architect, craftsman or master builder whose individual works have influenced the development of the city
- e-9. Its unique location as a singular physical characteristic which represents an established and familiar visual feature of a neighborhood community or the city

; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Jefferson Street Historic District at the West Side of Jefferson St. between Mason St. and Wells St. excluding 419-433 E. Wells St., further described as:
