Substitute resolution relative to the acceptance and funding of the 2020 from the Greater Milwaukee Foundation for the Birthing M.O.M.S. (Moms Offering Moms Support) Grant.

This resolution authorizes the Health Department to accept and fund the 2020 Birthing M.O.M.S. (Moms Offering Moms Support) Grant from the Greater Milwaukee Foundation in the amount of \$25,000 provided by the grantor with no city match. The purpose of the grant is to provide mothers with free, lead safe kits prior to hospital discharge containing educational materials, cleaning supplies, a water filter pitcher and a 1-year supply of refills.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Greater Milwaukee Foundation for the 2020 Birthing M.O.M.S. (Moms Offering Moms Support) Grant to provide mothers with free, lead safe kits prior to hospital discharge; and

Whereas, The operation of this grant project from 01/01/20 to 12/31/20 would cost \$25,000 provided by grantor with no city match and; now, therefore, be it

1. Commit funds within the Project/Grant Parent of the 2020 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled 2020 Birthing M.O.M.S. (Moms Offering Moms Support) Grant:
