

WHEREAS, two sealed bids were received by the deadline of 2:00 PM (CST) on February 28, 2020; and

WHEREAS, the sealed bids were received and publicly opened on February 28, 2020, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Roofed Right America, a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$998,631.00; therefore, be it,

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Roofed Right America for for Roofing for Phase 4B Townhomes at Westlawn Gardens Phase 2; and, be it
