Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$12,472,000 for a total estimated cost of these projects being \$13,189,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$12,472,000. The total estimated cost of these projects is \$13,189,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

N. 48th St. - W. Villard Ave. to W. Rohr Ave. (WT410200675) File Number 190037: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$225,000). The total estimated cost of this project including the requested amount is

\$240,000. This project is anticipated to be completed during the 2020 construction season.

#### 2nd Aldermanic District

W. Glendale Ave. - N. 66th St. to N. 67th St. (WT410200662) File Number 181588: Water Main Extension. (Nonassessable Water Fund Budget Line 5010 -- \$0; (Nonassessable Water Fund Budget Line 6410 -- \$75,000). The total estimated cost of this project including the requested amount is \$90,000. This project is anticipated to be completed during the 2020 construction season.

W. Hope Ave. - N. 66th St. to N. 73rd St. (WT410200666) File Number 181588: Relaying water main. This project is anticipated to be completed during the 2020 construction season.

(Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$425,000). The total estimated cost of this project including the requested amount is \$450,000. This project is anticipated to be completed during the 2020 construction season.

N. 67th St. - W. Hope Ave. to W. Marion St. (WT410200660) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$230,000). The total estimated cost of this project including the requested amount is \$245,000. This project is anticipated to be completed during the 2020 construction season.

N. 70th St. - W. Capitol Dr. to W. Congress St. (WT410200664) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$840,000). The total estimated cost of this project including the requested amount is \$880,000. This project is anticipated to be completed during the 2020 construction season.

This project is anticipated to be completed during the 2020 construction season.

(Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$220,000). The total estimated cost of this project including the requested amount is \$235,000. This project is anticipated to be completed during the 2020 construction season.

W. Douglas Ave. - N. 119th St. to 425' +/- west of N. 119th St. (SM495200011) File Number 191657: Installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$113,000). (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$540,000). The total estimated cost of this project including the requested amount is \$575,000. This project is anticipated to be completed during the 2020 construction season.

W. Vienna Ave. - N. 76th St. to N. 80th St. (WT410200645) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$435,000). The total estimated cost of this project including the requested amount is \$460,000. This project is anticipated to be completed during the 2020 construction season.

W. Columbia St. - N. 13th to N. 14th St. (SM495190011) File Number 181588: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$117,000). The total estimated cost of this project including the requested amount is \$129,000. This project is anticipated to be completed during the 2020 construction season.

W. Hampton Ave. (south side) - N. Sherman Blvd. to N. 46th St. (WT410200648) File Number 181588: Relaying water main and Lead Replacement. This project is anticipated to be completed during the 2020 construction season.

Crack filling of various streets by contract (ST211200101) File Number 191263: (Nonassessable Reconstruction Paving Fund -- \$450,000). The total estimated cost for this project including the

requested amount is \$500,000. This project is anticipated to be completed during the 2020 construction season.
