The purpose of the project is provide comprehensive women's health family planning services to men and women throughout the year at the Keenan and Southside Health Centers.

Whereas, The operation of this grant project from 01/01/20 to 12/31/20 would cost \$261,000 grantor share with no city match; now, therefore, be it
