WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57981 during the period April 29, 2020 through May 15, 2020 for HVAC for Phase 4B Townhomes at Westlawn Gardens Phase 2; and

WHEREAS, one sealed bid was received by the deadline of 2:00 PM (CDST) on May 15, 2020; and

WHEREAS, the sealed bid was received and publicly opened on May 15, 2020, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, DMJ Services LLC dba Action Heating & Cooling, a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$980,000.00; therefore, be it,

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with DMJ Services LLC dba Action Heating & Cooling for HVAC for Phase 4B Townhomes at Westlawn Gardens Phase 2; and, be it
