Substitute resolution relative to acceptance and funding of the Wisconsin Well Woman Program Grant from the State of Wisconsin - Department of Health Services.

This resolution authorizes the Health Department to accept and fund the Wisconsin Well Woman Program Grant from the State of Wisconsin - Department of Health Services in the amount of \$650,000 grantor share 100% with no city match. The project will provide screening and lifestyle interventions to women ages 35 - 64 who are eligible for the Wisconsin Well Woman Program (Milwaukee Breast and Cervical Cancer Program).

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin -Department of Health Services to provide screening and lifestyle interventions to low-income and under-served women 35-64 years of age; and

Whereas, The operation of this grant project from 07.01.2020 to 06.30.2021 would cost \$650,000 provided entirely by the grantor 100% with no city match; now, therefore, be it

1. Commit funds within the Project/Grant parent of the 2020 Special Revenue-Grant and Aid Projects Fund, the following amounts for the program titled Wisconsin Well Woman Program Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project/Grant levels; budget to these Project/Grant values the amount required under the grant agreement; and, be it

1. Expend from the amount appropriated sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;

- 2. Expend from the 2020 grant budget funds for specific items of equipment;
- 3. Expend from the 2020 grant budget funds for training and out-of-town travel by departmental staff; and
- 4. Enter into subcontracts as specified in the grant budget.
