THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$1,749,000 for a total estimated cost of these projects being \$4,928,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$1,749,000. The total estimated cost of these projects is \$4,928,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

# 3rd Aldermanic District

E. Kenwood Blvd. - N. Lake Dr. to 950' east of N. Lake Dr. (WT410200643) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$270,000). The total estimated cost of this project including the requested amount is \$290,000. This project is anticipated to be completed during the 2021 construction season.

# 4th Aldermanic District

N. 19th St. - W. McKinley Ave. to N. 19th Ct. (WT410200655) File Number 181588: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$115,000). The total estimated cost of this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2020 construction season.

# 6th Aldermanic District

N. 5th St. - N. Dr. Martin Luther King Jr. Dr. to W. Keefe Av.(ST214200102) Asphalt pavment resurfacing, replace curb and gutter as necessary. (Developer Deposit funds -- \$55,000) The total cost of this project including the requested amount is \$55,000. This project is anticipated to be completed during the 2020 construction season.

#### 7th Aldermanic District

N. 23rd St. - W. Locust St. to W. Chambers St. (SM495190045) File Number 190870: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$142,000). The total estimated cost of this project including the requested amount is \$154,000. This project is anticipated to be completed during the 2020 construction season.

N. 26th St. - W. Chambers St. to W. Burleigh St. (SM495190055) File Number 190870: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$187,000). The total estimated cost of this project including the requested amount is \$199,000. This project is anticipated to be completed during the 2020 construction season.

#### 10th Aldermanic District

S. 68th St. - 330' north of W. Main St. to W. Main St. (SM495200017) File Number 191657: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$81,000). The total estimated cost of this project including the requested amount is \$93,000. This project is anticipated to be completed during the 2020 construction season.

N. 68th St. - W. Stevenson St. to 275' north of W. Stevenson St. (SM495200018) File Number 191657: (Nonassessable Sewer Maintenance Relay Fund -- \$64,000). The total estimated cost of this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2020 construction season.

#### 15th Aldermanic District

W. Locust St. - N. 27th St. to N. 29th St. (SM495190032) File Number 190743: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$48,000). The total estimated cost of this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2020 construction season.

W. Wright St. - N. 32nd St. to N. 35th St. (SM495190052) File Number 190870: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$57,000). The total estimated cost of this

project including the requested amount is \$69,000. This project is anticipated to be completed during the 2020 construction season.

N. 34th St. - W. Meinecke Ave. to W. Wright St. (SM495190053) File Number 190870: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$162,000). The total estimated cost of this project including the requested amount is \$174,000. This project is anticipated to be completed during the 2020 construction season.

N. 36th St. - W. Clarke St. to W. Center St. (SM495190051) File Number 190870: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$168,000). The total estimated cost of this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2020 construction season.

Handicap Ramp work to meet ADA requirements for 2016 High Impact Projects (ST216200108): File Number 200229: (Nonassessable High Impact Streets -- \$200,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2020 construction season.

Handicap Ramp work to meet ADA requirements - High Impact 2019 Projects- north side contract (ST216190101) File Number 181227: (Nonassessable High Impact Streets -- \$150,000 additional funds). The total estimated cost for this project including the requested amount is \$1,850,000. This project is anticipated to be completed during the 2020 construction season.

Handicap Ramp work to meet ADA requirements - High Impact south side 2020 Projects (ST216200101) File Number 191263: (Nonassessable High Impact Streets -- \$50,000 additional funds). The total estimated cost for this project including the requested amount is \$1,350,000. This project is anticipated to be completed during the 2020 construction season.
