RESOLVED, by the Board of Directors of Travaux Inc. that it hereby authorizes and approves accepting the bid of and entering into a contract with Bohmann & Vick Inc. for Plumbing (BC-9.1) for Remodeling at Becher Court; and, be it

FURTHER RESOLVED, that funds for these services will come from Becher Court Mixed-Financing; and, be it
