WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57996 during the period July 8, 2020 through July 22, 2020 for Painting (BC-12.1) for Remodeling at Becher Court; and

WHEREAS, three sealed bids were received by the deadline of 2:00 PM (CDST) on July 22, 2020; and

WHEREAS, the sealed bids were received and publicly opened on July 22, 2020, during which the bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Common Links Construction LLC, a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$262,000.00; therefore, be it,

RESOLVED, by the Board of Directors of Travaux Inc. that it hereby authorizes and approves accepting the bid of and entering into a contract with Common Links Construction LLC for Painting (BC-12.1) for Remodeling at Becher Court; and, be it

FURTHER RESOLVED, that funds for these services will come from Becher Court Mixed-Financing; and, be it

FURTHER RESOLVED, that the proper officers of Travaux Inc. be and hereby are authorized and directed to properly execute said contract for and on behalf of Travaux Inc.; and, be it

FURTHER RESOLVED, that if any extensions of the time of performance are needed the officers of Travaux Inc. may approve such request without any further action of the Board of Directors Travaux Inc.; and, be it

FURTHER RESOLVED, that all of above is contingent upon receiving the approval of the U.S. Department of Housing and Urban Development, if required; and, be it

FURTHER RESOLVED, that all acts previously performed relative to this matter by the Board of Directors of Travaux Inc. and the officers of Travaux Inc. be and hereby are approved, ratified, and confirmed in all respects.
