### THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$340,000 for a total estimated cost of these projects being \$3,065,000. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$340,000 with the total cost estimated to be \$3,065,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

# 3rd Aldermanic District

N. Humboldt Ave. - E. North Ave. to E. Keefe Ave. (WT410210692) Water Main Rehabilitation. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$124,000). The total estimated cost of this project including the requested amount is \$2,325,000. This project is anticipated to be completed during the 2021 construction season.

5th Aldermanic District

IH41/US45 - W. Burleigh St. to W. Good Hope Rd. (WT410210002) Hydrant Alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2021 construction season.

Village of Brown Deer

W. Bradley Rd. - N. 51st St. to N. 60th St. (ST214200103) High impact asphalt overlay. (Developer paving funds -- \$175,000) The total cost of the project including the requested amount is \$350,000. The agreement was approved through resolution 200232. This project is anticipated to be completed during the 2020 construction season.

## Greenfield

W. Layton Ave. - S. 27th St. to S. 43rd St. (WT410210003) Hydrant Alteration. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$24,000). The total estimated cost of this project including the requested amount is \$360,000. This project is anticipated to be completed during the 2021 construction season.
