THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$260,000 for a total estimated cost of these projects being \$630,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$260,000 with the total cost estimated to be \$630,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications: NPR

4th Aldermanic District

N. 9th St. - W. Wells St. to W. State St. (ST211200145) Install Walk and Curb and Gutter as necessary (Nonassessable Reconstruction Paving Fund -- \$15,000). The total estimated cost of this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2020-21 construction season.

10th Aldermanic District

W. Center St. - N. 76th St. to N. 92nd St. (City of Wauwatosa Portion) (ST214200105) High Impact Asphalt Surface (Developer Paving Fund-- \$180,000) The total estimated cost of this project including the requested amount is \$355,000. This work was done in 2018. This resolution sets up the funds for the City of Wauwatosa portion.

11th Aldermanic District

W. Honey Creek Dr. - W. Morgan Ave. to W. River Bend Dr. (SM499200013) Bioswales. (Stormwater Quality - Non Assessable Water Quality Projects to meet TMDL Requirements, \$15,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2021 construction season.

City Wide

Alley Maintenance (ST212180122) Asphalt Alley Patching By Maintenance. (Nonassessable Alley Paving Fund -- \$ 50,000). The total estimated cost of this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2020-21 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
