Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$441,000 for a total estimated cost of these projects being \$658,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$441,000. The total estimated cost of these projects is \$658,000. Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

#### 10th Aldermanic District

W. State St. - N. 46th St. to 450' west of N. 50th Pl. (SM495200031) File Number 200229: Sanitary sewer relay and lining. (Infiltration/Inflow Reduction Fund -- \$211,000). The total estimated cost of this project including the requested amount is \$223,000. This project is anticipated to be completed during the 2020 construction season.

### 14th Aldermanic District

S. 11th St. (& Water easement-684) - W. Cleveland Ave. to 435' south of W. Cleveland Ave. (WT410160636) File Number 150118: Relaying water main and replace original lead service. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$105,000). The total estimated cost of this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2021 construction season.

#### Greenfield

S. 72nd St. - 360' north of W. Bottsford Ave. to W. of Bottsford Ave. (WT410170603) File Number 151521: Abandoning water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$85,000). The total estimated cost of this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2021 construction season.

#### Various Aldermanic Districts

Bridge Safety Inspection - Federal and State mandated safety inspection of in-service bridges.(BR100200102) File Number 191555 (City share Non-assessable Structure Fund \$40,000, Additional Funds). The total estimated cost for this project is \$215,000. This project is anticipated to be completed during the 2020 construction season.
