Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$4,287,000 for a total estimated cost of these projects being \$4,580,800.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$4,287,000. The total estimated cost of these projects is \$4,580,800.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

## 1st Aldermanic District

W. Custer Av. - N. 13th St. to N. Green Bay Av. (Sponsored by the City of Glendale) (ST211190103) File Number 181382: Asphalt pavement resurfacing, replace ADA ramps as necessary (Nonassessable Reconstruction Paving Fund -- \$121,000). The total estimated cost of this project

including the requested amount is \$136,000. This project is anticipated to be completed during the 2021 construction season.

W. Custer Av. - N. Dexter Av. to N. 27th St. (Sponsored by the City of Glendale) Including the intersection of N. 25th St. and W. Rohr Av. (ST211190104) File Number 181382: Asphalt pavement resurfacing, replace ADA ramps as necessary (Nonassessable Reconstruction Paving Fund -- \$110,000). The total estimated cost of this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2021 construction season.
