Whereas, In 1923, the City of Milwaukee constructed a 15-inch diameter combined sewer in the vacated alley between North Old World 3<sup>rd</sup> Street and West Vel R Phillips Avenue from 241' +/- South of West State Street to West State Street; and

Whereas, The land is now owned by JS 1924, LLC (the condominium unit 1 owner) and JS1962 Holdings, LLC (the condominium unit 2 owner) (the condominium being the one created by the Declaration of Condominium of the Amended and Restated Journal Square Condominium); and

Whereas, The said sewer no longer serves the public interest; and

Whereas, JS 1924, LLC and JS1962 Holdings, LLC, as the respective unit 1 and unit 2 owners, have agreed to accept ownership of said sewer, therefore be it
