Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$10,476,499 for a total estimated cost of these projects being \$11,096,499.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$10,476,499. The total estimated cost of these projects is \$11,096,499.

requested amount is \$1,135,000. This project is anticipated to be completed during the 2021 construction season.
