Substitute resolution relative to the acceptance and funding of the Wisconsin Supplemental Nutrition Assistance Program-Education from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to accept and fund the Wisconsin Supplemental Nutrition Assistance Program-Education from the State of Wisconsin Department of Health Services in the amount of \$20,000. The purpose of the Wisconsin Supplemental Nutrition Assistance Program-Education grant is to support nutrition education programming, community gardens and urban agriculture, healthy food retail support in existing and new businesses, City policy, zoning, and practice, Healthy Food Financing initiatives, creation of a community commercial kitchen, resident leadership and engagement, and other things.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin Department of Health Services to increase access to and consumption of healthy foods; and

Whereas, The operation of this grant program from 10/01/20 to 09/30/21 would cost \$20,000 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the State of Wisconsin Department of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant account of the 2020 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Supplemental Nutrition Assistance Program-Education Grant:Project/Grant GR0002000000

- 3. Enter into subcontracts as detailed in the grant budget; and, be it
