Substitute motion relating to the locations of various Milwaukee County Transit System bus stops. This motion authorizes the establishment of new bus stops at various locations throughout the city. It is moved, By the Common Council of the City of Milwaukee, that establishment of new bus stops at the following locations is authorized:

North Downer Avenue, southbound, at East Locust Street (northwest corner of intersection).

West Hampton Avenue, westbound, at a point approximately 150 feet west of North Green Bay Avenue.

North Green Bay Avenue, northbound, at a point approximately 185 feet north of West Courtland Avenue.

North Green Bay Avenue, northbound, at West Hampton Avenue (southeast corner of intersection).

West Bradley Road, eastbound, at a point approximately 340 feet east of North 111th Street.

West Bradley Road, eastbound, at a point approximately 300 feet west of North 107th Street.

North 107th Street, northbound, at West Donna Drive (southeast corner of intersection).

North 107th Street, northbound, at a point approximately 20 feet south of the crosswalk over

North 107th Street on the south side of West Brown Deer Road (southeast corner of intersection).

West Brown Deer Road, eastbound, at the west right-of-way line of North 95th Street extended (southwest corner of intersection).

West Brown Deer Road, eastbound, at North 91st Street (southwest corner of intersection).

North 107th Street, southbound, at a point approximately 250 feet south of West Brown Deer Road (turn lane).

North 107th Street, southbound, at West Donna Drive (northwest corner of intersection).

North 107th Street, southbound, at the north right-of-way line of West Villa Avenue extended (northwest corner of intersection).

North 107th Street, southbound, at a point approximately two-tenths of a mile north of West Bradley Road (immediately north of the south driveway entrance to the Sunset Ridge Apartment Homes).

North 107th Street, southbound, at West Bradley Road (northwest corner of intersection).

West Bradley Road, westbound, at North 124th Street (northeast corner of intersection).

West Brown Deer Road, westbound, at a point approximately 150 feet west of North 91st Street.

West Lapham Boulevard, eastbound, at South 9th Street (southwest corner of intersection).

West Lapham Boulevard, westbound, at South 9th Street (northeast corner of intersection).

South 13th Street, northbound, at a point approximately 20 feet north of the north right-of-way line of West Granada Street extended).

North Dr. Martin Luther King, Jr., Drive, southbound, at a point approximately 110 feet northwest of the crosswalk over King Drive immediately west of North Port Washington Avenue.

West Hampton Avenue, eastbound, at North Teutonia Avenue (southwest corner of intersection).

West Wells Street, westbound, at a point approximately 120 feet west of North James Lovell Street.

West Wells Street, westbound, at North 9th Street (northeast corner of intersection).

North 12th Street, northbound, at a point approximately 120 feet north of West Wells Street.

West Clybourn Street, westbound, at North 5th Street (southeast corner of intersection).

West Villard Avenue, westbound, at a point approximately 90 feet west of the first alley entrance on the north side of West Villard Avenue, west of North 85th Street.

West Villard Avenue, westbound, at North 87th Street (northeast corner of intersection).

West Layton Avenue (right-turn lane), eastbound, at South Howell Avenue (southwest corner of intersection).

North 124th Street, northbound, at a point approximately 80 feet north of the signalized intersection on North 124th Street at the entrance to Sam's Club.

West Bradley Road, eastbound, at a point approximately one-tenth of a mile west of North 111 th Street (directly across from the driveway of the property located at 11310 West Bradley Road).

North 107th Street, northbound, at a point approximately two-tenths of a mile north of West Bradley Road (directly across from the north driveway entrance to the Sunset Ridge Apartment Homes).

North 107th Street, northbound, at West Villa Avenue (southeast corner of intersection).

North 107th Street, northbound, at West Heather Avenue (southeast corner of intersection).

West Brown Deer Road, westbound, at North 96th Street (northeast corner of intersection).

North 107th Street, southbound, at a point approximately 105 feet south of West Heather Avenue.

West Bradley Road, westbound, at the Oak Leaf Trail crossing.
