The purpose of this grant is to provide peer support to women and families related to breastfeeding education and/or support. This grant supports participants currently enrolled in the WIC program.

Whereas, Common Council File # 201329 authorizes the Health Department to accept and fund the 2021 Women, Infants and Children's (WIC) Breast Feeding Peer Counseling Grant from the State of Wisconsin Department of Health Services for the purpose of providing peer support to women and families related to breastfeeding education and/or support; supporting participants currently enrolled in the WIC program. This grant provides a grantor share in the amount of \$36,815 with no city match.
