Whereas, the FEMA agreed to pay for Covid-19 vaccines administered in the City of Milwaukee; and

Whereas, The City of Milwaukee incurred expenditures that are eligible for reimbursement by FEMA and required greater than anticipated vaccination sites to reach the underserved population,

Whereas, The City Comptroller has certified greater than anticipated revenue in the amount up to \$4,000,000, pursuant to s. 304-91,

Pursuant to s. 304-91, I hereby certify that the money required for this is anticipated to be realized on or before December 31, 2021 and to be expended only for the purpose in this resolution.
