Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$20,000 for a total estimated cost of these projects being \$822,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$20,000 with the total cost estimated to be \$822,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

City of Milwaukee Parking Lot at 1002 W. Maple St. - (SM499210011) Installing Bioswales. (Nonassessable Water Quality Fund -- \$5,000). The total estimated cost of this project is \$147,000. This project is anticipated to be completed during the 2022 construction season.

City of Milwaukee Parking Lot at 1650 S. 12th St. - (SM499210013) Installing Bioswales. (Nonassessable Water Quality Fund -- \$5,000). The total estimated cost of this project is \$257,000. This project is anticipated to be completed during the 2022 construction season.

City of Milwaukee Parking Lot at 1657 S. 12th St. - (SM499210010) Installing Bioswales.
