Substitute resolution relative to the acceptance and funding of the Communicable Disease Prevention grant from the Wisconsin Department of Health Services, Division of Public Health.

This resolution authorizes the Health Department to accept and fund the Communicable Disease Prevention Grant project from the Wisconsin Department of Health Services, Division of Public Health in the amount of \$28,000. The purpose of the project is increase trainings and competencies around communicable disease issues.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services, Division of Public Health for enhancing capabilities around STI strategic planning; and

Whereas, The operation of this grant project from 07.01.2021 to 6.30.2022 would cost \$28,000 entirely provided by the grantor; now, therefore, be it

- 4. Enter into subcontracts and leases as detailed in the grant budget.
