This resolution authorizes the Health Department to accept and fund the 2021 - 2022 Validation of Non-Clinical Self-Collected Specimens Grant from the National Association of County & City Health Officials (NAACHO) in the amount of \$146,310 100% grantor share with no city match. The purpose of the project is to focus on designing, piloting and validating the self-collection of genital and extra-genital (rectal and throat) specimens in a nonclinical (e.g. home) setting for testing by the public health laboratory.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the National Association of County and City Health Officials to focus on designing, piloting and validating the self-collection of genital and extra-genital (rectal and throat) specimens in a nonclinical (e.g. home) setting for testing by the public health
