This resolution authorizes the Health Department to accept and fund the 2021-2024 AMD Sequencing & Analytics Project E: Emerging Issues Grant from the Division of Public Health (DHS/DPH) and Center of Disease Control (CDC) in the amount of \$1,370,256 100% grantor share with no city match. The purpose of the grant is to enable state and local health departments to make long-term investments in workforce and infrastructure to support sequencing and analytic capacity building in microbial genomics and bioinformatics, as well as accelerate further development of AMD capacity.
