The purpose of the grant is to strengthen surveillance, detection, and preparedness through the Laboratory Response Network (LRN),

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Department of Health Services and Center of Disease Control to strengthen surveillance, detection, and preparedness through the Laboratory Response Network (LRN); and

Whereas, The continued operation of this grant program from 08.01/2021 to 07.31.2022 would cost \$142,523 100% grantor share with no city match; now, therefore, be it

1. Commit funds within the Project/Grant parent of the 2021 Special Revenue Grant and Aid Projects Fund, the following amounts for the program titled Epidemiology and Laboratory Capacity Grant:
