THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$500,000 for a total estimated cost of these projects being \$6,984,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$500,000 with the total cost estimated to be \$6,984,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

N. 25th St. - 125' +/- north of W. Capitol Dr. to W. Hope Ave. (SM495210054) Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project is \$232,000. This project is anticipated to be completed during the 2022 construction season.

2nd Aldermanic District

W. Medford Ave. - W. Custer Ave. to W. Sheridan Ave. (SM495210044) Sanitary Sewer Lining.

(Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost of this project including the requested amount is \$62,000. This project is anticipated to be completed during the 2022 construction season.
