Sewer Easement - E. Kenwood Blvd. 770' +/- east of N. Lake Dr. to E. Hampshire St. 735' +/- east of N. Lake Dr. (SM495210040) File Number: 210701 Relaying Sanitary and Storm Sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$124,000). The total estimated cost of this

(Nonassessable Water Fund Budget Line 6410 -- \$100,000). The total estimated cost of this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2022 construction season.

N. Summit Ave. - E. Hartford Ave. to 201' north of E. Hartford Ave. (SM495200061) File Number 201139: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$60,000). The total estimated cost of this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2022 construction season.
