

WHEREAS, the Housing Authority of the City of Milwaukee (HACM) received an allocation of Low Income Housing Tax Credits from the Wisconsin Housing and Economic Development Authority for the rehabilitation of 122 rental housing units; and

WHEREAS, HACM will incorporate Carver Park LLC to be the owner entity of this Project; and

WHEREAS, HACM is the developer and the Managing Member of Carver Park LLC through its wholy owned Limited Liability Company, Carver Park Development LLC; and

WHEREAS, the President recommends that Travaux, Inc. enter into a contract with Carver Park LLC, the owner of Townhomes at Carver Park project; now, therefore, be it
