A substitute ordinance relating to ethics and harassment training for elected officials, cabinet members and appointees.

303-5-14 rc

This ordinance provides that each elected official, member of the mayor's cabinet and appointee to a plural body complete ethics and harassment training provided by the department of employee relations or the department's designee within 120 days of an election or appointment and once every 4 years thereafter.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 303-5-14 of the code is repealed and recreated to read:

303-5. Standards of Conduct.

- 14. ETHICS AND HARASSMENT TRAINING REQUIRED.
- **1.** Ethics and harassment training provided by the department of employee relations or the department's designee shall be completed by:
- a. Elected officials.
- b. Members of the mayor's cabinet specified in s. 62.51(1)(a)., Wis. Stats.
- c. Appointees to all plural bodies as defined in s. 320-1-2.
- **2.** Ethics and harassment training shall be completed within 120 days of election or appointment and once every 4 years thereafter.
