Substitute resolution relative to the reallocation of HOME funding from Community Advocates, Inc. to affordable housing projects.

This resolution authorizes the reallocation of Community Advocates, Inc. 2020 HOME reprogramming award in the amount of \$1,670,178.83 to affordable housing projects.

Whereas, The Common Council of the City of Milwaukee has previously approved the HOME award of \$1,670,178.83 to Community Advocates, Inc. for Tenant Based Rental Assistance; and

Whereas, Community Advocates, Inc. has notified the Community Development Grants Administration (CDGA) of their decision to no longer accept this funding, CDGA is recommending the funds be reallocated to affordable housing projects as recommended in **Attachment A**; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Community Development Grants Administration is authorized to distribute the HOME funding as stated above; and, be it

Further Resolved, That funded projects shall submit budget and activity reports in amounts and according to any conditions approved by the Common Council and in accordance with File Number 74-92-5v, to the Community Development Grants Administration and the City Comptroller for review and approval; and, be it

Further Resolved, That payments for HOME cost incurred shall be paid in accordance with approved
