THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$2,287,000 for a total estimated cost of these projects being \$15,096,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$2,287,000 with the total cost estimated to be \$15,096,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

## 1st Aldermanic District

N. Hopkins St. - 70' +/- south of W. Rohr Ave. (ext) to W. Custer Ave. (SM495210111) Relaying storm sewer. Storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$147,000. This project is anticipated to be completed during the 2022 construction season.

## 3rd Aldermanic District

N. Shepard Ave. - E. Newport Ave. to E. Edgewood Ave. (SM495210119) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$265,000. This project is anticipated to be completed during the 2022 construction season.

## 4th and 12th Aldermanic Districts

6th Street Cable-Stayed Bridges over the Menomonee River (BR100220105): In Depth Inspection of Cable-Stayed Bridges. (City Share Non-assessable Structure Fund - \$300,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2022 construction season.

The total estimated cost of this project including the requested amount is \$40,000. This project is anticipated to be completed during the 2022 construction season.

N. 38th St. - W. Keefe Ave. to W. Roosevelt Dr. (SM495210113) Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost of this project including the requested amount is \$508,000. This project is anticipated to be completed during the 2022 construction season.

#### 10th Aldermanic District

N. 47th St. - W. Vliet St. to W. Cherry St. (SM495210110) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$119,000. This project is anticipated to be completed during the 2022 construction season.

#### 14th Aldermanic District

S. 14th St. - 650' +/- north of W. Dakota St. to W. Dakota St. (SM495210115) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2022 construction season.

## 15th Aldermanic District

W. Wright St. - N. 35th St. to N. 36th St. (SM495210109) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$25,000). The total estimated cost of this project including the

N. 37th St. - W. Clarke St. to W. Center St. (SM495210118) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$172,000. This project is anticipated to be completed during the 2022 construction season.

Miscellaneous Bridge Capitol Repairs (BR100220104): Bridge Maintenance construction repairs to various projects. (City Share Non-assessable Structure Fund - \$150,000). Bridge Indirect and Administration (BR100220101): Preliminary engineering and administration of bridge projects. (City share Non-assessable Structure Fund \$100,000). Water Alterations - Developer Funded (WT430220300) Alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$49,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2022 construction season.

Work by MWW Prior to Paving (WT410220730) Alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$14,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2022 construction season.

Work Done by Contractor/Paving (WT410220750) Alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$19,000). The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2022 construction season.

Work Done by Contractor/Sewer Alterations (WT410220770) Alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$14,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2022 construction season.

Suburban Plan Reviews (WT440220800) Plan Review. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$49,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2022 construction season.

Water Repairs/Distribution Referred (WT410220840) Water main repairs. (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$14,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2022 construction season.

Material Inspection at Various Locations (WT410220880) Inspection (Nonassessable Water Fund Budget Line 5010 -- \$ 1,000; Nonassessable Water Fund Budget Line 6410 - \$29,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2022 construction season.

2022 Sewer Work Prior To Paving (SM495220500) (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost of this project including the requested amount is \$1,500,000. This project is anticipated to be completed during the 2022 construction season.
