THE CHAIR

A substitute ordinance relating to parking controls.

This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-2 of the Code relating to No Stopping is amended by adding the following:

On the west side of North Prospect Avenue from a point 350 feet south of East Brady Street to a point 58 feet south thereof

On the west side of North Prospect Avenue from a point 466 feet south of East Brady Street to a point 80 feet south thereof

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On the north side of East Becher Street from South Kinnickinnic Avenue to South 1st Street, from 3:30 PM to 5:30 PM except Saturday and Sunday except where No Parking is in effect"

"On the north side of East Becher Street from the east line of the first railroad overpass east of South 1st Street to a point 50 feet east thereof at any time"

"On the south side of East Becher Street from South 1st Street to South Kinnickinnic Avenue, from 7:00 AM to 9:00 AM except Saturday and Sunday"

"On the south side of East Becher Street from the east line of the first railroad overhead east of South 1st Street to a point 70 feet east thereof, at any time"

"On the south side of East Becher Street from South Kinnickinnic Avenue to South Robinson Avenue, from 3:30 PM to 5:30 PM except Saturday and Sunday, and where No Parking is in effect"

"On the north side of West Becher Street from a point 100 feet west of the west curb line of South 1st Street to a point 70 feet west thereof, at any time"

"On the north side of West Becher Street from the west curb line of South 1st Street to a point 180 feet west thereof at any time"

"On the north side of West Becher Street from a point 310 feet west of South 1st Street to a point 70 feet further west thereof at any time"

"On the north side of West Becher Street from a point 340 feet west of the west curb line of South 1st Street to a point 100 feet further west thereof at any time"

"On the north side of West Becher Street from the east curb line of South 2nd Street to a point 50 feet east thereof, at any time"

"On the south side of West Becher Street from South 1st Street to a point 120 feet west at any time"

Part 3. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of East Becher Street from South 1st Street to South Kinnickinnic Avenue

On the south side of East Becher Street from South Kinnickinnic Avenue to a point 100 feet west

On the north side of West Becher Street from South 4th Street to a point 580 feet east

On the south side of West Becher Street from South 1st Street to South 4th Street

Part 4. Section 101-23-4-c of the Code relating to One-Hour Parking is amended by adding the following:

On the north side of West Glendale Avenue from West Appleton Avenue to a point 120 feet east from 7:00 AM to 7:00 PM except Sunday

Part 5. Section 101-23-4-k of the Code relating to Parking for the Physically Disabled is amended by adding the following:

On the west side of North 9th Street from a point 230 feet north of West Wells Street to a point 200 feet north thereof

Part 6. Section 101-23-10-a of the Code relating to No Parking During Winter Months is amended by adding

the following:

On the south side of West Marion Street from North Sherman Boulevard to North 44th Street

Part 7. Section 101-24-1 of the Code relating to Tow-Away Zones is amended by adding the following:

On the west side of North Prospect Avenue from a point 350 feet south of East Brady Street to a point 58 feet south thereof

On the west side of North Prospect Avenue from a point 466 feet south of East Brady Street to a point 80 feet south thereof
