THE CHAIR

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$20,000 with the total cost estimated to be \$742,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 1st Aldermanic District

N. 28th St. - W. Fairmount Ave. to W. Lincoln Creek Pkwy (SM499220010) Installing Brick Pavers. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000) The total estimated cost of this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2022 construction season.

13th Aldermanic District

S. 15th Pl. - 605' +/- north of W. Dakota St. to W. Oklahoma Ave. (SM495220010) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost of this project including the requested amount is \$542,000. This project is anticipated to be completed during the 2022 construction season.
