Whereas, The operation of this grant program from 01.01.2022 to 12.31.2022 would cost \$52,000 grantor share and no city match; now, therefore, be it

1. Commit funds within the Project/Grant account of the 2022 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Community Based Doulas Grant:
