Resolution approving a 1<sup>st</sup> Amendment to a Lease Agreement with the DeLong Company, Inc. This resolution approves a 1<sup>st</sup> Amendment to a Lease Agreement with the DeLong Company, Inc. for 4 parcels of real property comprised of 4.64 acres located on Port Milwaukee's South Harbor Tract. Whereas, The Common Council ratified and approved a Lease Agreement between the DeLong Company, Inc., and the City of Milwaukee, by and through its Board of Harbor Commissioners, on September 22, 2020; and

Whereas, The terms of the lease are 15 years commencing November 1, 2020 and ending on October 31, 2035; and

Whereas, The lease can be extended for 3 successive periods of 5 years each, ending at maximum on October 31, 2050; and

Whereas, The DeLong Company, Inc. will be permitted to use Port property for purpose of receiving, handling, storing, packaging, and delivery of dried distillers grains with solubles or other agribusiness products and commodities; and

Whereas, The Board of Harbor Commissioners at its meeting of February 10, 2022 acted by unanimous vote of the Board to grant the 1<sup>st</sup> Amendment to the Lease Agreement; now, therefore, be it
