THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$59,025 for a total estimated cost of \$188,300.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$59,025. The total estimated cost of these projects is \$188,300.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 14th St. - W. Capitol Dr. to W. Fiebrantz Ave. (ST211210252) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,945; Nonassessable Reconstruction Paving Fund --

\$500). The total estimated cost for this project including the requested amount is \$6,600. This project is anticipated to be completed during the 2022 construction season.

N. 21st St. - W. Olive St. to W. Congress St. (ST211210254) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$3,635; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$15,700. This project is anticipated to be completed during the 2022 construction season.

N. 37th St. - W. Silver Spring Dr. to W. Thurston Ave. (ST211210203) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,825; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$13,300. This project is anticipated to be completed during the 2022 construction season.

N. 54th St. - W. Villard Ave. to W. Custer Ave. (ST211210204) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$4,670; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$15,900. This project is anticipated to be completed during the 2022 construction season.

N. 63rd St. - W. Congress St. to W. Ruby Ave. (ST211210243) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,450; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$6,600. This project is anticipated to be completed during the 2022 construction season.

N. 63rd St. - W. Hope Ave. to W. Marion St. (ST211210244) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,500; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$6,600. This project is anticipated to be completed during the 2022 construction season.

N. 69th St. - W. Hope Ave. to W. Marion St. (ST211210246) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,385; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$6,600. This project is anticipated to be completed during the 2022 construction season.

W. Bobolink Ave. - W. Appleton Ave. to N. 114th St. (ST211210185) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$10,750; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$20,600. This project is anticipated to be completed during the 2022 construction season.

N. 6th St. - W. Meinecke Ave. to W. Wright St. (ST211210247) Install traffic calming speed hump(s). W. Auer Ave. - N. 25th St. to N. 26th St. (ST211210266) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$960; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$6,400. This project is anticipated to be completed during the 2022 construction season.

N. 52nd St. - W. Mill Rd. to W. Hassel Ln. (ST211180163) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$6,095; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$20,600. This project is anticipated to be completed during the 2022 construction season.

#### 10th Aldermanic District

W. Michigan St. - N. 91st St. to N. 93rd St. (ST211210274) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,805; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$11,200. This project is anticipated to be completed during the 2022 construction season.

#### 15th Aldermanic District

W. Clarke St. - N. 11th St. to N. 12th St. (ST211210291) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$200; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$7,800. This project is anticipated to be completed during the 2022 construction season.

W. Hadley St. - N. 41st St. to N. Grant Blvd. (ST211210293) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$270; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$6,200. This project is anticipated to be completed during the 2022 construction season.

W. Wright St. - N. Sherman Blvd. to N. 47th St. (ST211210292) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,005; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$16,800. This project is anticipated to be completed during the 2022 construction season.

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved That a portion of the speed hump projects will be utilizing ARPA (American Rescue Plan Act) funds: The project/grant number is RG1515236101; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects N. 14th St. (ST211210252), N. 21st St. (ST211210254), N. 54th St. (ST211210204), N. 63rd St. (ST211210243), N. 63rd St. (ST211210244), N. 69th St. (ST211210246), W. Bobolink Ave. (ST211210185), N. 6th St. (ST211210247), N. 6th St. (ST211210248), N. 24th Pl. (ST211190177), N. 44th St. (ST211210265), W. Auer Ave. (ST211210266), N. 52nd St. (ST211180163), W. Michigan St. (ST211210274), W. Clarke St. (ST211210291), W. Hadley St. (ST211210293), and W. Wright St. (ST211210292) will be billed after January 1, 2024, but not before 12 months after the project contract has been completed.
