Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,137,000 for a total estimated cost of these projects being \$5,568,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,137,000. The total estimated cost of these projects is \$5,568,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

N. 31st St. - W. Atkinson Ave. to W. Glendale Ave. (WT410220655) File Number 201552: Relaying water main and Lead replacement of service. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$105,000). The total estimated cost of this project including the requested amount is \$120,000. This project is anticipated to be completed during the

2022 construction season.

N. 32nd St. - W. Hampton Ave. to 200' North of W. Hampton Ave. (WT410220634) File Number 201552: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$120,000). The total estimated cost of this project including the requested amount is \$135,000. This project is anticipated to be completed during the 2022 construction season.

W. Glendale Ave. - N. 30th St. to N. 32nd St. (WT410220654) File Number 201552: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$195,000). The total estimated cost of this project including the requested amount is \$210,000. This project is anticipated to be completed during the 2022 construction season.

This project is anticipated to be completed during the 2022 construction season.

The total estimated cost of this project including the requested amount is \$181,000. This project is anticipated to be completed during the 2022 construction season.

Nonassessable Water Fund Budget Line 6410 -- \$300,000). The total estimated cost of this project including the requested amount is \$320,000. This project is anticipated to be completed during the 2022 construction season.

This project is anticipated to be completed during the 2022 construction season.

Nonassessable Water Fund Budget Line 6410 -- \$400,000). The total estimated cost of this project including the requested amount is \$420,000. This project is anticipated to be completed during the 2022 construction season.

W. Fiebrantz Ave. - N. 82nd St. to N. 84th St. (WT410220677) File Number 201552: Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$180,000). The total estimated cost of this project including the requested amount is \$195,000. This project is anticipated to be completed during the 2022 construction season.

W. Grantosa Dr. - 225' East of N. 100th St. to N. 100th St. (WT410220614) File Number 201552: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. This project is anticipated to be completed during the 2022 construction season.

This project is anticipated to be completed during the 2022 construction season.

Nonassessable Water Fund Budget Line 6410 -- \$265,000). The total estimated cost of this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2022 construction season.

N. 36th St. - 310' +/- South of W. Chambers St. to W. Chambers St. (SM495210034) File Number 210059: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$84,000).
