Substitute resolution relating to legislative bills.

This resolution expresses the City of Milwaukee's support for Wisconsin Senate Bill 410 (SB-410), Impounding of vehicles used in certain traffic offenses, conditional on the following amendments being made to the bill:

- 1. Eliminating the provision allowing for impounding of a vehicle for license suspension.
- 2. Allowing vehicles to be impounded up to 90 days, instead of for 90 days.
