Resolution approving a final Certified Survey Map for land located north of West Birch Avenue and west of North 60th Street to create four lots and dedicate an alley for public right-of-way purposes, in the 2nd Aldermanic District

This resolution approves a final Certified Survey Map that divides one parcel into four parcels to facilitate development and to dedicate public right-of-way in order to create an alley.

Whereas, The Milwaukee Code of Ordinances (“MCO”), Chapter 119-5, Subdivision Regulations, requires City Plan Commission (“CPC”) approval, conditional approval or disapproval of all Certified Survey Maps (“CSMs”), which provide dedication of land to the City of Milwaukee (“City”) for public purposes; and

Whereas, The City received one final CSM, a copy of which is attached to this Common Council File, which dedicates land to the City for public purposes; and

Whereas, In compliance with the above-referenced chapter of the MCO, CPC has reviewed and approved said CSM; now, therefore, be it
