THE CHAIR

A substitute ordinance relating to fees for late filing of applications for scale licenses and scanning devices and the fee for a duplicate scanning device license.

60-91-3-b am

This ordinance amends the fee for filing of a late renewal application for a scale license from \$53 to \$49 to make the fee increase in 2010 consistent with similar fees.

The ordinance provides 2 additional fees relating to scanning devices which will be licensed for the first time beginning in 2010. The first additional fee is \$49 for filing a late application for a scanning device license. The second additional fee is \$10 for a duplicate scanning device license. The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 60-91-3-b of the code, as amended by file number 090259, effective January 1, 2010, is amended to read:

60-91. Weighing and Measuring Device Licenses.
