THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,038,500 for a total estimated cost of \$3,240,930.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$1,038,500. The total estimated cost of these projects is \$3,240,930.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions,

determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

#### 1st Aldermanic District

W. Glendale Ave. - N. 27th St. to N. 32nd St. (ST21100134) File Number 040588: Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (17-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$10,400; Nonassessable Reconstruction Paving Fund -- \$205,000). The total estimated cost for this project including the requested amount is \$252,000. This project is anticipated to be completed during the 2010 construction season.

#### 4th and 12th Aldermanic Districts

S. 2nd St. - W. National Ave. to a point north of The Menomonee River (ST320021301)(2245-01-00) File Number 010810: Concrete pavement reconstruction, replace all curb and gutter, sidewalk and driveway approaches, sodding (4-foot width of tree border area), grading, and narrowing the roadway from 58 feet to 50 feet.

Grantor Non-Reimbursable Paving Fund--\$ 1,056,695;  
Grantor Reimbursable Paving Fund -- \$158,505  
City Share Non-assessable Paving Fund--\$ 277,500.00;  
City Share Assessable Paving Fund -- \$26,300

These funds are to be transferred to the construction account (ST320021311) (2245-01-70).

Previously authorized for street construction: \$0.00

Current estimated cost of total project including this resolution: \$ 2,366,830.35

Original estimated cost of the project (File Number 010810): \$ 1,832,420.00

This project is anticipated to be completed during the 2010 construction season.

#### 6th Aldermanic District

E. Garfield Ave. - N. Humboldt Ave. to N. Weil St. (ST211089004): Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$1,500; Nonassessable Reconstruction Paving Fund -- \$8,500). The total estimated cost for this project including the requested amount is \$10,000. This project is anticipated to be completed during the 2010 construction season.

N. Weil St. - E. Garfield Ave. to E. North Ave. (ST211089002): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$4,100; Nonassessable Reconstruction Paving Fund -- \$6,000). The total estimated cost for this project including the requested amount is \$10,100. This project is anticipated to be completed during the 2010 construction season.

N. 15th St. - W. Burleigh St. to W. Ring St. (ST211100140) File Number 090760: Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$10,000; Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is

\$25,000. This project is anticipated to be completed during the 2010 construction season.

8th Aldermanic District

Alley between W. Lapham St., W. Mitchell St., S. 29th St. and S. 30th St. (ST212090109) File Number 081390: Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary. (Assessable Alley Paving Fund - \$33,300; Nonassessable Alley Paving Fund -- \$40,000). The total estimated cost for this project including the requested amount is \$76,000. This project is anticipated to be completed during the 2010 construction season.

10th Aldermanic District

N. 91st St. - W. Hawthorne Ave. to W. St. Paul Ave. (ST211020138) File Number 080123: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$10,400; Nonassessable Reconstruction Paving Fund -- \$155,000). The total estimated cost for this project including the requested amount is \$198,000. This project is anticipated to be completed during the 2010 construction season.

14th Aldermanic District

E. Bennett Ave. - S. Ellen St. to a Point West of S. Ellen St. (ST211050114) File Number 090105: Asphalt pavement resurfacing, replace all curb and gutter, sidewalk and driveway approaches, sodding (6-foot width of tree border area), grading, tree removal where necessary, and narrowing the roadway from 36 feet to 32 feet. (Assessable Reconstruction Paving Fund -- \$5,300; Nonassessable Reconstruction Paving Fund - 2010 Budgeted Funds- \$78,500). The total estimated cost for this project including the requested amount is \$97,000. This project is anticipated to be completed during the 2010 construction season.

S. Taylor Ave. - E. Malvern Pl. to E. Euclid Ave. (ST211080110) File Number 061382: Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (7-foot width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$16,700; Nonassessable Reconstruction Paving Fund -- \$140,000). The total estimated cost for this project including the requested amount is \$206,000. This project is anticipated to be completed during the 2010 construction season.

Whereas, The report of the Commissioner of Public Works has been filed with the City Clerk; and

Whereas, Notices have been sent to all interested persons and public hearings held; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed

with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the City Engineer and the Commissioner of Public Works are hereby authorized to negotiate and enter into an agreement with the State of Wisconsin, Department of Transportation for the City to undertake construction management duties on the following project: S. 2nd St. (ST320021301); and, be it

Further Resolved, That the City Engineer is authorized and directed to approve and make periodic payments to the State of Wisconsin, Department of Transportation after receipt of invoices from said State for the city's share of the costs for said project: S. 2nd St. (ST320021301); and, be it

Further Resolved, That upon the completion of project: S. 2nd St. (ST320021301) and a determination of the actual costs, it is understood that if the City of Milwaukee's share is less than the amount previously paid, the difference will be refunded to said City; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects: W. Glendale Ave. (ST21100134), S. 2nd St. (ST320021301), E. Garfield Ave. (ST211089004), N. Weil St. (ST211089002), N. 15th St. (ST21100140), Alley Lapham St. (ST212090109), N. 91st St. (ST211020138), E. Bennett Ave. (ST211050114) and S. Taylor Ave. (ST211080110) will be billed after January 1, 2012, but not before 12 months after the project contract has been completed.
