THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$95,000 for a total estimated cost of these projects being \$1,610,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$95,000 with the total cost estimated to be \$1,610,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

2nd Aldermanic District

N. 86th St. - W. Silver Spring Dr. to W. Fond Du Lac Ave. (ST211220177) Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund - \$25,000). The total

estimated cost of this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2023-24 construction season.

W. Fiebrantz Av. - N. 66th St. to N. 68th St. (ST211210218) Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Non-Assessable Reconstruction Paving Fund - additional funds, \$5,000.) The total estimated cost of this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2023 construction season.

5th Aldermanic District

W. Glendale Av. - N. 84th St. to N. 87th St. (ST211210198): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund - additional funds, \$5,000) The total estimated cost for this project including the requested amount is \$205,000. This project is anticipated to be completed during the 2023 construction season.

7th Aldermanic District

N. 37th St. - N. Hopkins St. to W. Hampton Ave. (ST211220178) Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund - \$20,000). The total estimated cost of this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2023-24 construction season.

10th Aldermanic District

W. Hadley St. - N. 51st St. to W. Appleton Ave. (ST211220179) Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund - \$30,000). The total estimated cost of this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2023-24 construction season.

15th Aldermanic District

W. Wright St. - N. 35th St. to N. Sherman Blvd. (ST211190198) Placing an asphalt overlay on the existing pavement. Removing and replacing all curb and gutter. Removing and replacing concrete sidewalk and driveway approaches where necessary. Doing all the necessary grading pertaining to said work. (Nonassessable Reconstruction Paving Fund - additional funds, \$10,000). The total estimated cost of this project including the requested amount is \$410,000. This project is anticipated to be completed during the 2023 construction season.

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
