THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,755,000 for a total estimated cost of these projects being \$19,005,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,755,000 with the total cost estimated to be \$19,005,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 1st Aldermanic District

N. 12th St. - W. Wilson Dr. to W. Birch Ave. (WT410230673): Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2023 construction season.

N. 13th St. - 330' South of W. Lawn Ave. to W. Custer Ave. (WT410230677): Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line
